Chair's Report



The Board of Directors held six meetings over the course of the previous year, including the Annual General Meeting in May 2021.

A very significant appointment in the life of the Foundation was made after an extensive period of planning and consultation, with Felicity Costigan becoming our first Chief Executive Officer. Felicity commenced in March 2021 and has already cemented herself into the leadership team of the diocese and been very proactive in becoming involved in the various activities and programs of the Foundation. This has included commencing new programs, including a bequest program, and fostering and supporting present programs. Felicity has also had considerable success in conjunction with Nicola Templeton in obtaining grants from new government and philanthropic sources.

Over the course of the past year Ken Spackman left his diocesan role and resigned as a director. The Registrar, Malcolm Tadgell, replaced him as a director and treasurer. We also welcomed to the board a new director, Carolyn Clark, filling a casual vacancy that was confirmed at the AGM. Two new directors were elected at the 2021 AGM, Chris Arnold AM and the Revd Colleen Arnold-Moore. We now have a near full board of directors for the first time in many years.

A major initiative in relation to governance has just been commissioned by the directors. Advice has been commissioned in regards to the possibility of consolidating the present structure of the organisation, which includes the Melbourne Anglican Foundation Ltd itself and six further entities. Pending the recommendations we receive, we will then review our governance structures to improve efficiency, including subcommittees and a Board Charter. The intention is to make our governance less complex and more streamlined, so that we are able to engage more effectively, and more nimbly, with a wider section of the church and general community.

I continue to be very grateful for, and appreciative of, the considerable efforts and dedication of my fellow directors, and of the small Foundation staff team. Together we remain highly committed to our vision to resource the mission of the Anglican Church and achieve its aims to be a transformative force for Christ and for good across Melbourne and Geelong.

CEO's Report



The Impact of COVID-19 on Victorians continues to be severe and far reaching. Here at the **Melbourne Anglican Foundation (MAF)**, we have seen the challenges faced by the parishes in the Anglican Diocese of Melbourne and we are heartened by the willingness of our donors to continue to respond to the needs of the vulnerable in our community.

I have also worked to further develop MAF's work with Parish Partnerships and along with Nicola Templeton, have for the first time, gained support for our projects from State and Federal Governments.

I am extremely proud of the way the staff of MAF; Donor Management Administrator, Fiona Langton and Nicola Templeton, Director of Development and Communications, have responded and delivered for the needs of our project partners and donors. Together with our dedicated Chairperson, Bishop Bradley Billings and the supportive and informed members of the MAF Board, we continue to work as a thriving team throughout this extraordinary time of great humanitarian need.

Inside this annual report I hope you will gain a sense of the work of the Foundation and the extraordinary potential we, through donations from our donors and philanthropic partners, have, to support even greater endeavours into next year and beyond.

Following two months of intense project planning work, Allchurches Trust UK approved three-year funding of New Ministry Presence/ Church Planting in Melbourne to the value of \$250,000. First tranche of \$79,299.92 received late December 2020.

Other development and fundraising work in 2020 focused on:

- Applications and acquittals
- TMA articles and advertising.
- Two permitted project visits in May to Geelong and November to Mernda and Dandenong
- Assisting several churches with grant applications (to government and non-government organisations) for those suffering as a result of the impact of COVID-19.

- Appointment of new CEO, **Felicity Costigan**, March 2021 to:
 - Lead strategy, expand fundraising and operational efficiency
 - Review governance structure and arrangements
 - Expand the Board (as outlined by Chairperson)
 - Review strategic goals and priorities.
- MAF staff scheduled and facilitated meetings for the new MAF CEO Felicity Costigan to meet with church supported and enabled programs, including:
 - holding **key meetings** with Executive Officers and CEOs of Trusts and Foundations which Melbourne Anglican Foundation works with annually.
 - meeting Bishop and Canons for **New Ministry Presence** and **Church Planting** to establish good working relationships.
 - meeting Bishops, Archdeacons and key ADOM staff in **Parish Partnerships**.
 - Seeking fresh income streams for Anglican Diocese of Melbourne program **Preventing Violence Against Women**.
- Creating new focus for **Melbourne Anglican Chaplaincy Fund** as a well-positioned fund to receive grants for Anglican healthcare chaplains working on the front line in hospitals, care homes and aged care facilities.
- Seeking major funding support from the Victorian State Government for **refugees and new migrants** suffering due to direct impact of the coronavirus pandemic.
- Renewed marketing focus on **refugee and new migrant communities** that are without any government support such as Medicare, JobSeeker or JobKeeper.
- Renewing and refining **fundraising activities** positioned to meet new migrant needs in line with Federal Government funding.
- Creating and establishing a new **Melbourne Anglican Foundation Bequest Society** including:
 - establishing the name of the bequest society.
 - inviting a patron to lead the society.
 - creating a bequest brochure and inviting people to consider making Melbourne Anglican Foundation a named beneficiary in their will with the aim of establishing a bequest society.



Melbourne Anglican Benevolent Society Inc (MABS)

2020 saw many of our donors respond generously to the impact of the COVID-19 coronavirus. It was understandable that some donors felt unable to sustain their giving levels at those prior to COVID-19, but overwhelmingly financial gifts and support remained strong.

Donations and grants to the Melbourne Anglican Benevolent Society Inc (MABS) totalled \$1,128,892.43, revealing that despite great uncertainty due to COVID-19 after June 2020, Anglicans saw the need to keep supporting their church tax-deductible programs, enabled by MABS.

Melbourne Anglican Cultural Organisation (MACO)

Gifts in support of Melbourne Anglican Cultural Organisation totalled \$268,433 in 2020.

From March 2020, as COVID-19 restrictions were put in place, the impact was felt on worship music in Victorian Anglican churches. Live choral music, choirs and bands in church services effectively stopped. However, many Anglican churches quickly adapted to offer services online through Facebook or Zoom, enabling music to continue as a central part of Christian worship. 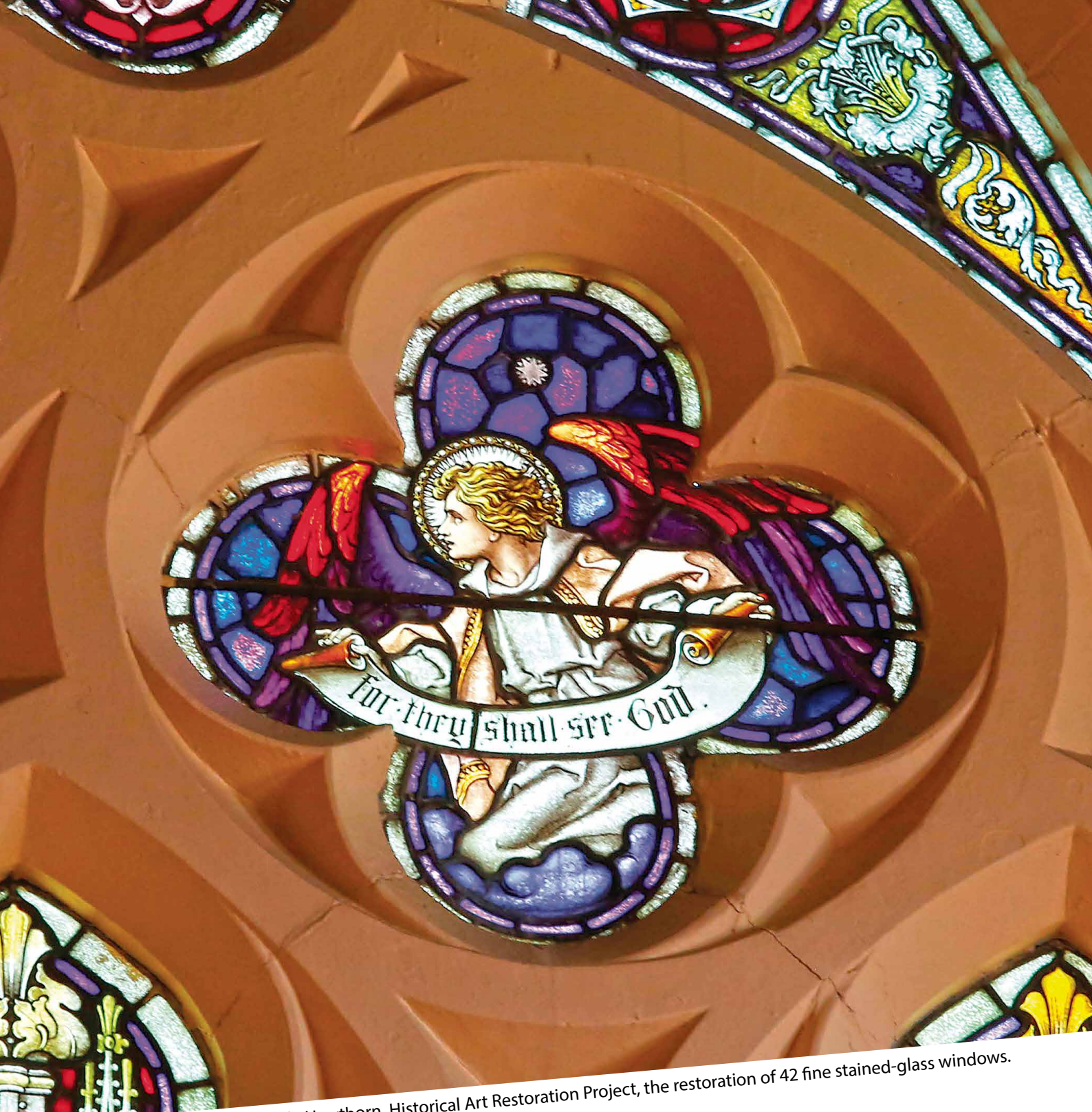

Melbourne Anglican Migrants and Refugees Settlement Fund (MRSF)

Many people in Melbourne's multicultural communities were assisted by the Federal Government's JobKeeper and JobSeeker payments.

However, some communities did not qualify to receive government assistance or support during the period of March to December 2020. Anglican clergy on the front line of need showed enormous resourcefulness and compassion, continuing to serve their congregations and giving of themselves sacrificially in time and kind.

The Melbourne Anglican Migrants and Refugees Settlement Fund (MRSF) responded by assisting with grants to larger community projects. Projects focused on the provision of Necessitous Need Emergency Relief through food programs; support for in-language information about COVID-19; activities and online workshops for culturally and linguistically diverse communities; online content for children and youth struggling with the pandemic, historical trauma, depression and how to continue with their schooling; assistance with outreach to migrant women and their children to assist with navigating the changing news around the pandemic.

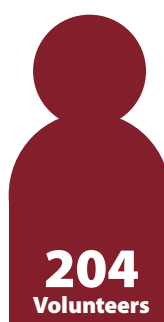

Melbourne Anglican Youth Ministry Fund (Youth)

Throughout 2020, youth work in the Anglican Diocese of Melbourne continued.

Prior to COVID-19 Melbourne lockdowns, outreach would typically take place in person on a Friday or Sunday afternoon, as most participants were normally available weekly at these times. Though these times did not alter, what emerged was an online version (or as close as possible version) of face-to-face meetings, games and laughter, reflections, workshops, prayer and Bible study, and above all, friendship, love and companionship.

Not surprisingly, the impact of COVID-19 has deeply affected outreach. Comments by young leaders reveal just how much.

- *There is a disconnect in relationships; it has been difficult to care for young people online which has led to the fringe people engaging less or not at all. Online is not attractive if you don't have a friend.*
- *It has been harder for us to engage in online platforms as people are weary from sitting in front of a screen on top of the general malaise.*
- *We have been calling the youth, however they aren't a generation that want to talk on the phone so innovating through dropping off parcels or things like that has worked to a degree.*
- *The youth and leaders' hope for future events such as camps or group outings has been declining rapidly. They tend to express low excitement so as not to get excited because they fear cancellations.*
- *We have noticed an increase in mental health issues such as depression, anxiety and online fatigue. It's harder and harder to engage.*
- *There is a negative relational impact from not seeing people as regularly; declining creativity with length of online ministry; less energy to give; it is difficult to plan because it's always postponed or cancelled; the constantly changing, waiting for information, making decisions and leading people through this is tiring, amounting to a 'decision-fatigue'.*
- *One good thing has been that one of our youth has stepped up in offering to organise our weekly online game for Friday night but otherwise, it's been pretty bleak. It's getting wearisome.*
- *Numbers and energy are way down; people are withdrawing until they can see a way out.*

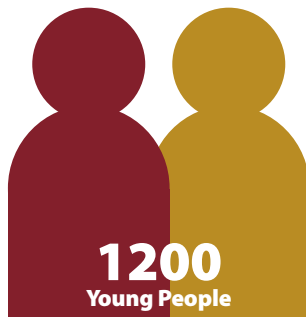
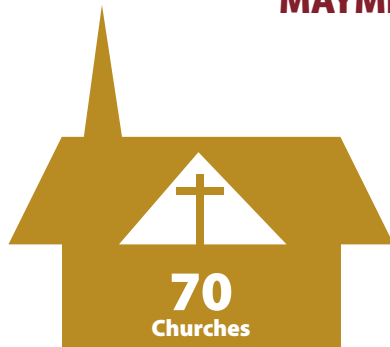

Melbourne Anglican Chaplaincy Fund (Chaplaincy)

Our Anglican chaplains provide emotional and spiritual care to patients in public hospitals, their families and hospital staff.

The COVID 19 pandemic has highlighted and reinforced the role of hospital chaplains as essential health workers.

Levels of stress in hospitals, particularly in acute settings like ICUs, has increased dramatically and chaplains are playing a key role in debriefing hospital staff.

Chaplains are playing an important role in educating patients and families about the rationale for social distancing restrictions, and other health care workers about the importance of self-care etc.

Social distancing has meant that limited numbers or no family members have been able to visit patients and this is extremely challenging for families, particularly at end of life for their loved ones. Chaplains have been involved in being with family members by video link as their loved ones have died or been given difficult news.

The grant was used to employ Anglican chaplains in public hospitals. The Anglican Diocese of Melbourne spends \$500,000 per annum on

employing dedicated hospital chaplains. The State Government provides a grant of \$100,000 per annum via the Spiritual Health Association, and this grant is likely to be removed. The remaining \$400,000 comes from contributions from parishioners and philanthropic grants. We are extremely grateful for the support of the Vera Moore Foundation and The Melbourne Anglican Foundation.

During 2020-2021, the Diocese employed ten Anglican chaplains across the Alfred, Austin, Royal Melbourne, Royal Children's, Monash, Eastern, Western, Northern and Geelong hospitals.

COVID-19 has meant that our chaplains have had to work remotely at times. This has necessitated transitioning to delivery of pastoral care via telephone or online platforms. This has been very challenging, and our chaplains have adapted extremely well.

The Diocese is committed to providing Anglican hospital chaplaincy in our public hospitals and we will continue to seek philanthropic support for this essential work to the broader community.

Special Programs 2020-21

Preventing Violence Against Women (PVAW)

Through a three-year funding commitment (2018-2021), the **Melbourne Anglican Foundation** was privileged to be one of several partners with the Anglican Diocese of Melbourne Preventing Violence Against Women (PVAW) program.

Highlights below illustrate an astonishingly successful program to date. Under the leadership of Program Manager Robyn Andreo-Boosey, the PVAW team achieved, through collaboration with the Anglican Church, government, and the prevention sector:

- training over 200 people from over 80 parishes, including online during the pandemic
- staff training and student teaching sessions at Ridley and Trinity Colleges
- coaching sessions and peer learning opportunities for lay and ordained church leaders
- a grant of \$120,000 from the Victorian Government and delivering one of five 18-month faith community prevention projects in partnership with **The University of Melbourne and the Multicultural Centre for Women's Health**. The Whole Church Pilot project worked intensively with five parish communities, developing resources and approaches which will be extended to other parishes
- a grant of \$190,000 from the Department of Families, Fairness and Housing to equip culturally and linguistically diverse Anglican communities to prevent violence against women
- work with the **Melbourne Anglican Foundation**, which brokered a grant of \$95,000 from the Collier Charitable Fund to implement the Program's 2021-2025 Strategic Plan
- family violence policy, procedures, and guidelines for diocesan staff and for parish communities
- establishing the Family Safety Champion role in parishes
- a PVAW communications strategy, church leader communications guide and resource creation templates
- PVAW Program communications: e-newsletter, YouTube, Facebook, and Twitter
- resources for churches, including a Bystander Action booklet, physical and digital posters, sermon outline tools, a Gender Justice Bible study series for small groups, youth and children's ministry resources, a church gender assessment tool, as well as YouTube video clips on a variety of topics
- raising awareness and inspiring reflection through the following events:
 - *Love, Respect and Courage*
 - *Reframing the Story*, a photography exhibition celebrating women leaders in the diocese, in partnership with St Paul's Cathedral
 - Webinar on COVID 19 and family violence.
- Preventing Violence Against Women forum
- DV (Domestic Violence) STOP Conference
- Domestic Violence Resource Centre Victoria webinar: 'Behind the Altar: Understanding how we change the story in faith-based settings'
- Faith Communities Supporting Healthy Family Relationships panel interfaith event as part of the UN 16 Days of Activism Against Gender-Based Violence

- participation in United Nations Commission on the Status of Women
- Guest presenter ABC Religion and Ethics Report.

The University of Melbourne's evaluation of the last three years of the PVAW Program found that it contributed to shifts in culture, attitudes, and practices within the Melbourne Anglican Diocese by supporting leaders to understand and take action to prevent and respond to violence against women and family violence.

Church Planting

In 2020, the Melbourne Anglican Foundation was pleased to receive a three-year commitment of AU \$250,000 from Allchurches Trust UK for New Ministry Presence/Church Planting in Melbourne.

Appointments to assist with the church planting portfolio

In its September 2020 meeting, Archbishop in Council passed a motion approving a proposal to fund the appointment of two Archbishop's Canons for Church Planting from the MATC Ministry Presence Initiative

(MMPI). This funding totals 0.8EFT of a clergy stipend for a period of three years. The Revd Canon John Sanderson and Canon Julie-anne Laird work with me in the development, implementation and monitoring of the portfolio, concentrating on church and ministry growth in both the urban and greenfield areas of the diocese.

Financials

2020 is a year that won't be forgotten quickly. COVID-19 and measures put in place to mitigate the health risks generated tremendous economic upheaval. Then as the vaccines availability and efficacy was proven and industries reopened growth rates spiked and markets recovered dramatically.

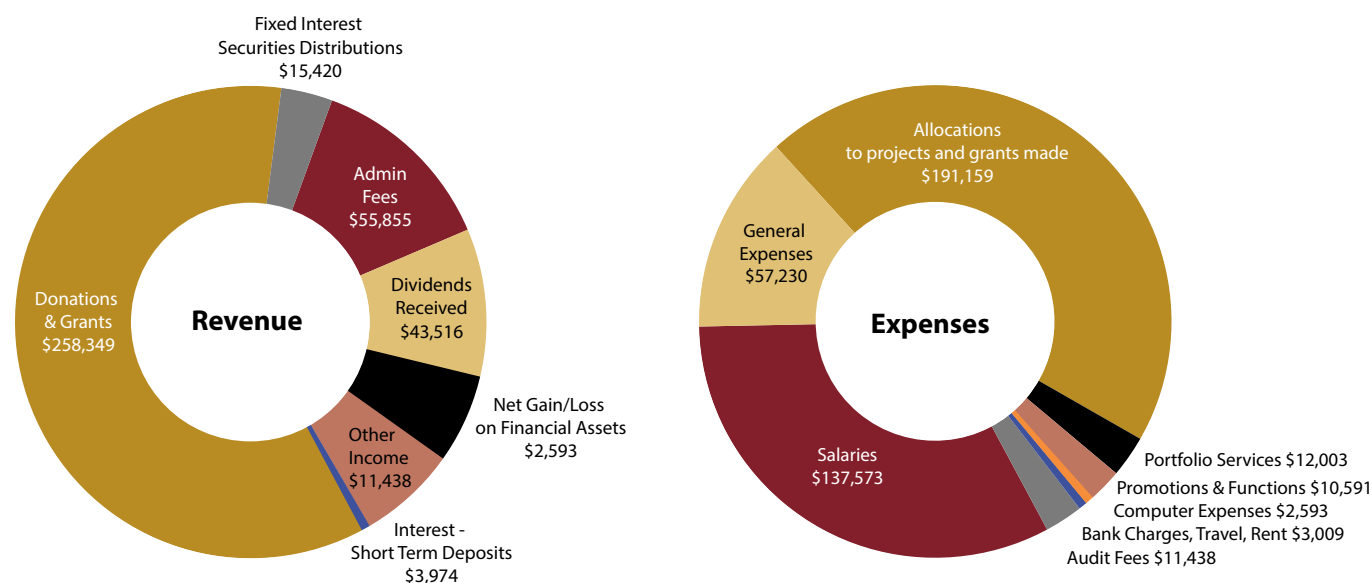
Apart from the volatile capital environment from quarter to quarter that had to be navigated we also saw income distributions reduced dramatically over the year as many large companies suspended or deferring their dividends to conserve capital in the face of continuing uncertainty.

During this time, the Melbourne Anglican Foundation corpus funds under management weathered these ups and downs admirably to end the year 0.46% higher on a very volatile year.
